

TERMS AND CONDITIONS OF PARTICIPANT REGISTRATION AND ONLINE TICKET SALES OF WARSAWDANCE.PL

§1. General provisions

1. Definitions

The “**Terms and Conditions**” refers to this Terms and Conditions of warsawdance.pl portal regulating in particular the registration and purchase of online tickets for the event, hereafter mentioned as “Terms and conditions”,

The “**Web Portal**” refers to the website accessible at the Internet address: <http://warsawdance.pl>, serving as a means of registration for Warsaw Dance Championships participants and purchase of online tickets for Warsaw Dance Championships and Warsaw Gala Ball, hereafter mentioned as “Web Portal”,

The “**Event 1**” refers to Warsaw International Dance Championships organized by the Organizer on September 22nd, 2018 at Double Tree by Hilton Hotel & Convention Center in Warsaw, subject to online ticket sales, hereafter mentioned as “Event 1”,

The “**Event 2**” refers to Warsaw Gala Ball organized by the Organizer on September 22nd, 2018 at Double Tree by Hilton Hotel & Convention Center in Warsaw, subject to online ticket sales, hereafter mentioned as “Event 2”,

The “**Organizer**” refers to Dansinn by Malitowski Sp. z o.o. with registered office in Warsaw, at 65 Mińska st., postal code 03-828 Warsaw, a company duly registered under the Polish law, entered into the Register of Entrepreneurs kept by the District Court of Warsaw 12th Economic Department of the National Court Register under no 0000642110, with a fully paid-up share capital in the amount of PLN 5.000,00, hereafter mentioned as “Organizer”,

The “**Participant**” refers to a natural person who either registered as a participant of Warsaw Dance Championships via the Web Portal and/or purchased an online ticket for Warsaw Dance Championships event and/or Warsaw Gala Ball or who purchased an online ticket for the event without registration as a Visitor, hereafter mentioned as “Participant”,

The “**Visitor**” - Participant - refers to an observer who purchased an online ticket for the event without registration via the Web Portal, hereafter mentioned as “Visitor”,

The “**Contestant**” refers to a natural person who registered as a participant of the Warsaw Dance Championships via the Web Portal with intent to participate in the competition, hereafter mentioned as “Contestant”,

The “**Online Ticket**” refers to an electronic ticket for an event, generated by the system of the Web Portal, hereafter mentioned as “Online Ticket”,

The “**Tpay.com**” refers to an electronic payment system providing fast, safe and convenient payment supplied through Krajowy Integrator Płatności SA with its registered office in Poznań, at 73/6 św. Marcin st., postal code 61-808 Poznań, a company duly registered under the Polish law, entered into the Register of Entrepreneurs kept by the District Court of Poznań - Nowe Miasto i Wilda 9th Economic Department of the National Court Register under no 000412357, with a fully paid-up share capital in the amount of PLN 5.494.980,00 zł, hereafter mentioned as “Tpay.com”,

The “**Sales Contract**” refers to the purchase of an Online Ticket for Event 1 and/or Event 2 from the Organizer or a Participant, hereafter mentioned as “Sales Contract”,

The “**Online Sales**” refers to sales of Online Tickets for the event via the Web Portal warsawdance.pl

2. By registering and purchasing an Online Ticket or by purchasing an Online Ticket you consent to this Terms and Conditions and all provisions thereof.

3. When registering and purchasing an Online Ticket, the Participant is obliged to provide accurate and complete data.

4. Lower prices of the Online Tickets apply up to August 1st, 2018. After August 1st, 2018 it will not be possible to purchase Online Tickets for the price applicable up to and including August 1st, 2018.

§2 General Terms and Conditions of Registration

1. The registration of Participants consists of 9 steps.

2. All the obligatory fields of the first registration form provided on the Web Portal should be filled in to register and purchase an Online Ticket. Only after all the obligatory fields of the registration form are completed, will it be possible to follow the next steps and move freely between steps and modules.
3. When registering via the registration form, it will be required that you provide: your first and last name, phone number, e-mail address, an address consisting of: country, postal code, city.
4. Only one age category can be selected.
5. Only one option: "Gentleman" or "Lady" can be selected.
6. The registration process may be completed at any point in order to proceed to payment for registration and/or Online Ticket purchase.
7. It is not necessary to choose an option for each step.

§3 Choosing the Ticket In the Registration Process

1. "Gold", "Silver" or "Bronze" packages can be selected. When a respective package is selected, a place at a table for the event will be booked automatically.
2. **Gold Package** includes: accommodation for 2 nights between 21-23.08.2018 in King Deluxe Room at Double Tree by Hilton hotel in Warsaw for one or two persons, access to vip lounge in Double Tree by Hilton hotel in Warsaw, individual transfer from the airport to Double Tree by Hilton hotel in Warsaw on 21.09.2018 and from the hotel to the airport on 23.09.2018 based on the flight information provided to the Organizer no later than 7 days before the start of the Event 1, 2 breakfasts on 22.09.2018 and 23.09.2018 at Double Tree by Hilton hotel in Warsaw within a time-frame selected by the Organizer, dinner on 21.09.2018 within a time-frame selected by the Organizer, lunch on 22.09.2018 at Double Tree by Hilton hotel in Warsaw within a time-frame selected by the Organizer, coffee break on 22.09.2018 at Double Tree by Hilton hotel in Warsaw within a time-frame selected by the Organizer, one or two tickets for Event 1, one or two Gold tickets for Event 2, individual Event 1 schedule, free access to Dansinn by Malitowski studio in the duration for Gold package.
3. **Silver Package** includes: accommodation for 2 nights between 21-23.08.2018 at Double Tree by Hilton hotel in Warsaw for one or two persons, transfer from the airport to Double Tree by Hilton hotel in Warsaw on 21.09.2018 and from the hotel to the airport on 23.09.2018 based on the flight information provided to the Organizer no later than 7 days before the start of the Event 1, 2 breakfasts on 22.09.2018 and 23.09.2018 at Double Tree by Hilton hotel in Warsaw within a time-frame selected by the Organizer, dinner on 21.09.2018 within a time-frame selected by the Organizer, lunch on 22.09.2018 at Double Tree by Hilton hotel in Warsaw within a time-frame selected by the Organizer, coffee break on 22.09.2018 at Double Tree by Hilton hotel in Warsaw within a time-frame selected by the Organizer, one or two tickets for Event 1, one or two Silver tickets for Event 2, individual Event 1 schedule, free access to Dansinn by Malitowski studio for the duration of Gold package.
4. **Bronze Package** includes: transfer from the airport to Double Tree by Hilton hotel in Warsaw on 21.09.2018 and from the hotel to the airport on 23.09.2018 based on the flight information provided to the Organizer no later than 7 days before the start of the Event, dinner on 21.09.2018 within a time-frame selected by the Organizer, lunch on 22.09.2018 at Double Tree by Hilton hotel in Warsaw within a time-frame selected by the Organizer, coffee break on 22.09.2018 at Double Tree by Hilton hotel in Warsaw within a time-frame selected by the Organizer, one or two tickets for Event 1, one or two Bronze tickets for Event 2, individual Event 1 schedule, free access to Dansinn by Malitowski studio for the duration of Gold package.
5. You can proceed to another step of the registration without selecting a package.
6. Provided that no package is selected, no less than 2 tournament tickets "competition tickets" - Event 1 tickets should be selected on step 7.
7. The tournament ticket - Event 1 ticket "competition ticket" is an entrance ticket and does not include a booking of a place at a table.
8. After selecting respective modules within each step, the final price for the Online Ticket will be displayed.
9. The Participant should select at least 5 single dances (4 for the American Smooth category) of each style to be able to apply for the Scholarship and/or WIDC Championship category.
10. After the end of the registration process and Online Ticket selection you will proceed to payment via Tpay.com.

11. The Organizer will issue a VAT invoice on the basis of payment made by the Participant for an Online Ticket.

§4 The Process of Ticket Selection by Visitors

1. The Visitor can purchase an Online Ticket for Warsaw Gala Ball and/or Warsaw Dance Championships.
2. Online Ticket for Warsaw Dance Championships grants access to the dance tournament hall and the lifestyle zone.
3. Online Tickets for Warsaw Gala Ball as mentioned in sec. 1 above, are available in three price options: Gold, Silver and Bronze. The tickets vary in price and location around the dance floor.
4. Purchase of Online Ticket for Warsaw Dance Championships without booking means:
 - A) the tournament ticket has no booking,
 - B) The tournament ticket includes ProAm tournament and lifestyle zone.

§5 Terms and Conditions of Online Ticket Sales

1. All the prices provided are gross prices, VAT included. Prices listed for each module are binding at the time of purchase.
2. The Sales Agreement is concluded via the Web Portal and requires that the following data of the Participant is provided:
 - a) for registration and purchase of the Online Ticket: first and last name, phone number, e-mail address, address: country, postal code, city, gender, age category, experience level of the participant - competitor,
 - b) For purchase of the Online Ticket by Visitor - first and last name, phone number, e-mail address, address: country, postal code, city.
3. The Organizer shall not be held liable for any false or incorrect data provided by the Participant.
4. Online Ticket purchase is concluded the moment the payment is credited to the account of the Organizer. If the payment is not confirmed within 48 hours, the registration process and ticket purchase is automatically cancelled.
5. Online ticket is a document entitling to participation in the event.
6. Inability to purchase Online Tickets is tantamount to lack of tickets for the event.

§ 6 Payment

1. The payment is made via Tpay.com.
2. The payment via Tpay.com can be made by wire transfer or by credit card.
3. Following the payment, the Participant shall receive the Online Ticket made out in his/her name to the provided e-mail address. The ticket shall include the date of the event and selected package. The Participant shall also receive a VAT invoice based on the data provided.

§ 7 Return Policy

1. The Organizer does not exchange tickets.
2. Return of tickets purchased online is possible only in the case of the event's cancellation.
3. Information on the event's cancellation is communicated to the Participant to the e-mail address provided in the form.
4. In the event of the ticket's return, as stated in sec. 2 above, the reimbursement shall be paid following issue of correcting invoice, in wire transfer to the bank account from which the payment was made or to the Participant's credit card.
5. Under art. 38 point 12 of Act of 30 May 2014 on Consumer Rights (Journal of Laws of 2017, item 683, as last amended) the Participant has no right of withdrawal from the online contract of ticket sales for the event.

§ 8 Complaints

1. Complaints regarding Online Ticket sales should be reported to the e-mail address: administrator@warsawdance.pl within 3 working days following the day the Participant obtained the Online Tickets.
2. Complaints regarding online ticket sales shall be handled no later than within 14 days following the day they were reported.
3. The complaint report shall include:
 - A) first and last name of the reporting person,

- B) Phone number,
 - C) E-mail address,
 - D) Scope of the complaint,
 - E) An accurate description of the complaint,
 - F) Reason for the complaint.
4. Complaints providing incorrect or incomplete data stated in sec. 3 above as well as inappropriate or insulting complaints will not be handled.
 5. The reporting person shall be informed about the way the complaint was handled by a message sent to the e-mail address provided therein.
 6. Shall the complaint be dealt with positively, the Organizer will, depending on the situation, reimburse the ticket price to the Participant or make necessary changes, if possible.

§9 Personal Data Protection

1. Personal data provided in the process of registration and Online Ticket purchase is administered by the Organizer.
2. Providing personal data in the process of registration and online tickets purchase is voluntary. Providing such data is tantamount to consenting to processing and storage of personal data by the Organizer in order to execute the process of registration and purchase of tickets and essential contact with the client, as stated in the Privacy Policy.
3. Providing personal data is tantamount to accepting this Terms and Conditions and Privacy Policy of Web Portal warsawdance.pl.

§ 10 Final Provisions

1. The Organizer reserves the right to cancel the event for a valid reason. In the event of cancellation, the Organizer shall not be held liable for the costs incurred by the Participants other than the price of the Online Ticket.
2. The Organizer reserves the right to change this Terms and Conditions for a valid reason. The Participant shall be notified of such change by a message sent to the provided e-mail address. The amended Terms and Conditions are binding for the Participant unless he/she refuses to accept the changes before the amended Terms and Conditions come into force. The amendment of the Terms and Conditions has no effect on the registration process and ticket purchase prior to it.
3. The Terms and Conditions are available at Web Portal warsawdance.pl.
4. The Terms and Conditions shall be applicable from 09.07.2018.
